ENFORCEMENT UPDATE

Enforcement Services would like to remind everyone that it's the responsibility of every owner or occupier of residential properties, vacant properties, and commercial buildings that have an adjoining sidewalk to clear snow and ice within 72 hours of a snow fall. Failure to do so can result

in fines and fees. It is also illegal to deposit snow on any roadway within the Town of Millet.

We would also like to remind everyone that has a fire hydrant to clear the snow three feet in all directions and fully clear to the street. In the event of a fire every second counts and inability to gain access to a water source will hinder fire department operations.
