
- Dress with warm insulating layers closer to the body, covering with wind and waterproof layers on the outside

# WASTE, ORGANICS & RECYCLING SERVICE UPDATES

The existing contract for waste collection with GFL expires at the end of 2023 so a request for quotes was issued. Three submissions were received, and Integrity Waste Solutions was awarded the contract for a three-year period starting January 1, 2024.

The final organics collection for GFL will be on December 18, 2023, both the organics and the carts will be collected on that day. Carts must be out by 7am as collection will be starting early. The final waste collection for GFL will be on December 29, 2023, both the waste and the carts will be collected on that day. Carts must be out by 7am as collection will be starting early.

Integrity will be dropping off organic carts December 18-22, 2023, with their first organics collection being January 9, 2024. Integrity will be dropping off waste carts December 18-22, 2023, with the first waste collection being January 4, 2024
