## Mike Jones - Director of Public Services

Public Services Director Mike Jones was in attendance to answer any questions Council may have. Councillor Brooks stated he felt the outdoor rink has undergone significant improvements from last year, Mr. Jones stated he has a plan and will be upgrading more each year as budget allows.

Councillor Pyle stated she was very happy with the new outdoor ice surface at the arena. Mr. Jones stated this was the first year and he plans to make it bigger and better each year.

Mayor Wadsworth enquired as to why street intersections were not being sanded. Mr. Jones stated that the sanding truck had been out of the commission for the past few weeks but that it would be back in operation the next day, Thursday January 24<sup>th</sup> 2019. Mr. Jones further advised Council that the Street Cleaning work performed in summer 2018 did include a second limited sweep prior to the CIB judges visit in July. He hopes to gain approval to purchase a different machine next year that would enable a thorough sweep and clean up to be achieved with just the first cleaning.
