BYLAW NO. 2020-15

A BYLAW OF THE TOWN OF MILLET

IN THE PROVINCE OF ALBERTA

TO AMEND BYLAW 2018/11 BEING THE LAND USE BYLAW

WHEREAS Section 639 of the Municipal Government Act, Chapter M-26, RSA requires municipalities to pass a Land Use Bylaw;

AND WHEREAS, Section 3.4 of the Land Use Bylaw 2018/11 establishes the authorities of the Municipal Planning Commission;

AND WHEREAS, Section 3.5 of the Land Use Bylaw 2018/11 establishes West Central Planning Agency (WCPA) as the subdivision authority for the Town of Millet;

AND WHEREAS, Schedule 12A establishes the fines for offences for non-compliance of the Land Use Bylaw 2018/11;

NOW, THEREFORE, the Council of the Town of Millet, duly assembled, amends Bylaw 2018/11 being the Land Use Bylaw as follows:

- 1. Deleted
- 2. That Section 3.1.5 be amended to read "The Subdivision Authority is hereby established, and such office shall be filled by the Chief Administrative Officer or such other person or persons as may be appointed in writing. All subdivision requests shall be referred to the Municipal Planning Commission for comment, with recommendations forwarded to Council. Subdivisions shall be finalized by a resolution of Council."
- 3. That Schedule 12A Fines and offences be replaced as follows:
