BACKGROUND/PROPOSAL

As you may recall at last year's budget, we stated the department would be coming forward soon for new SCBA (Self Contained Breathing Apparatus). We were anticipated this would be for 2024.

COSTS

The regular cost for an apparatus is \$13/14k per apparatus and the department will require 10 sets.

After meeting with East West Rural and explaining this was a huge hit to our municipality, they have offered to purchase these at their discount of \$8375 each this week and not bill the Town until January 2024. This will save the Town a total of \$39,165.00.

RECOMMENDATION

That council approve a pre-approval for the 2024 budget for the purchase of 10 SCBA, through East West Rural Society, to be invoiced in 2024.

11.6 Request for Utility Connection Agreement

BACKGROUND/PROPOSAL

In late 2022 Ryan Paggett purchased 5155 - 53 Avenue which is a single family home that was using a well to access water. The well has failed and beyond repair, and in accordance with the Town of Millet Bylaw 2022-02 being the Water and Sewer Regulations Section 7, the property owner is now required to connect to the Town's water distribution system.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES

Mr. Paggett has received quotes from contractors on the Town's Prequalified Contractor List and out of necessity has proceeded with the work which was done by Cobra for \$7,875 which was less than the estimated amount of \$9,850 plus GST. The cost for the connection was unplanned for Mr. Paggett and as the Town is requiring him to connect to the Town's distribution system more affordable alternatives are not available to him.

Mr. Paggett will be in attendance to address any questions or concerns council may have.

COSTS/SOURCE OF FUNDING

After discussion with Annette she does not see any issue with placing the charges on his property taxes. Similar annual payments are done in other communities for replacement of lead lines with no interest charged to the home owner.

RECOMMENDED ACTION:

Is Council willing to enter into an agreement with Mr. Paggett to have the charges for the connection to the Town's water distribution system to be paid by the Town and charged on his tax roll annually?

If so, would Council want to charge interest?

My name is Ryan Paggett and have lived in the Millet area for ten years, relocating to town approximately a year and a half ago. I have two children who are in Grade 1 and entering kindergarten at Griffiths Scott school.

I am writing you to formally request financial assistance from the town of Millet for an unexpected expense related to connecting my property to the town's water supply. As you may be aware, my property has been relying on a well for our water needs. Unfortunately, the well has recently failed and is no longer able to provide the necessary water supply to my property.

As a result of this unforeseen situation, I had to contact the town of Millet to connect my property to the town's water supply. The cost associated with this connection was much higher than I anticipated, and I am now facing financial hardship as a result.

I am respectfully requesting that the town consider providing me with assistance to cover the costs of connecting my property to the town's water supply. I would like to propose that the cost be attached to my taxes and repaid over three years.

occupant with a written notice at the last known address provided, also advising the property owner. Disconnection of services may apply and actions may be taken with a collection agency, if payment is not rendered within an allocated time and a re-connection fee will apply, as per Schedule "A".

- I) In the event that a historical account remains in arrears, the Town of Millet will notify the consumer with a written notice at the last known address provided, advising actions will be taken either with a Collection Agency or by action in any court of competent jurisdiction, if payment is not rendered within an allocated time.
- m) In addition to the method outlined above for recovery of outstanding rates and charges, the Town reserves the right to discontinue services to any property for charges for services or work remaining outstanding for a period of more than sixty (60) days.
- No person shall interfere with, damage, or make inaccessible any curb stop due to the construction of walks, driveways, etc.
- o) If it is required to make repairs due to inaccessibility, or damage to curb stops, the owners of the property serviced by said curb stops shall, in addition to the penalties of this bylaw, be required to assume all costs involved.

WELLS AND OTHER SOURCES OF WATER

- a) No well or other source of water, except the Town mains, shall be on use for domestic consumption in the Town excepting those premises which were utilizing a well or other source of water supply prior to third and final reading of this bylaw.
- b) Any such permission assumed as aforesaid may be withdrawn by order of the Town at any time without notice and no person shall use a well or other source of water supply after a permit for use of same has been withdrawn.
- c) Any person who makes application to be serviced by the water distribution system and such application is approved, shall not revert to any other supply source at a later date, but shall remain connected to the Town supply.
