REMINDER FROM ENFORCEMENT SERVICES

CATS RUNNING AT LARGE - LICENSING



The Town of Millet has had a large increase in complaints of cats running at large in Town. These are currently taking over a large majority of our bylaw calls.

Just a reminder, as per the Responsible Pet Owner by-law, no animal shall run at large within the Town of Millet. You could be subject to a fine of \$90 for first offence, \$150 for second offence and \$200 for any subsequent offences. If your animal is taken to the shelter, or does not have a license, there will be additional fines and fees.

Further be reminded that all cats must be licensed. If you have not yet licensed your cat, please do so, cost UNTIL MARCH 31, 2025 is \$30 for lifetime license, as of April 1st cost will be \$50 for spayed/neutered and \$100 for not spayed or neutered. 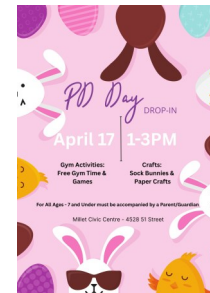
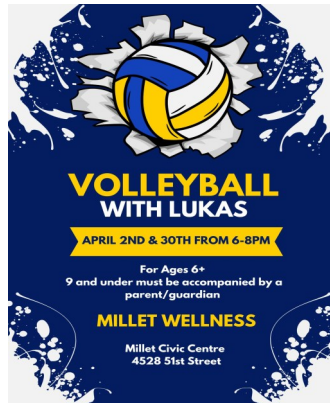
